If you lodge a proxy form for the Issuer or attend a particular meeting in person your standing proxy will be revoked for that meeting only.

This standing proxy appointment only applies to the CSN shown on this form. If your CSN changes for any reason, this appointment will not carry across to the new CSN.

To revoke this Standing Proxy for all meetings, you will need to do so in writing. Any notification revoking this Standing Proxy should be signed by the shareholder/s and be received by Link at least 48 hours prior to a relevant meeting.
